#### 3980 SHRI ABIR RANJAN BISWAS:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of eligible minority families and families of Person with Disabilities (PwDs) who are yet to be covered under the Pradhan Mantri Awas Yojana- Gramin (PMAY-G), State-wise;
- (b) the number of beneficiaries of PMAY-G who availed the loan up to ₹. 70,000, Statewise;
- (c) whether the funds given under PMAY-G to the beneficiaries have been revised considering the inflation in the construction material since the inception of the scheme; and
- (d) if so, the details thereof and if not, the reasons therefor?

- (a) The details of number of beneficiaries registered for assistance by the States/UTs under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) in Minority and Person with Disabilities (PwD) categories, number of beneficiaries to whom houses have been sanctioned and number of houses completed for such beneficiaries as on 31.03.2022 is given at **Annexure-I**.
- (b) The State-wise number of eligible beneficiaries of PMAY-G who availed the loan up to Rs. 70,000 is given at **Annexure-II**.
- (c) & (d) No Sir. There is no such proposal under consideration of this Ministry. The Union Cabinet has approved the continuation of PMAY-G beyond March 2021 till March 2024 as per the existing norms to complete remaining houses within cumulative target of 2.95 crore houses.
