#### STATUS OF EMRSS IN MAHARASHTRA

#### 3983. DR. VIKAS MAHATME:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the total number of operational Ekalavya Model Residential Schools (EMRSs) in the State of Maharashtra, the details thereof, including the number of children residents post COVID;
- (b) the number of proposed EMRSs and non-functional EMRSs in the State of Maharashtra;
- (c) what timeline does Government propose to functionalise the non-functional EMRSs; and
- (d) whether Government has made proposals for providing skill training and developments in EMRSs, if so, details thereof, and if not so, the reasons therefor?

#### ANSWER

# MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

- (a) to (c): A total number of 39 Ekalavya Model Residential Schools (EMRSs) are scheduled to be established in Maharashtra, out of which 36 have already been approved and 25 are reported to be functional as on date. The list of these functional EMRSs with the number of children enrolled during 2021-22 is attached at Annexure. Earnest efforts are being made to make all the schools functional and to complete the construction work subject to provision of suitable land by the State Government at the earliest, . State Government/State EMRS society also has the option of starting school in alternate building in the approved block pending completion of construction work.
- (d): For providing skill training and developments in EMRSs, collaboration has been done by National Education Society for Tribal Students (NESTS) with national apex bodies such as National Council of Educational Research and Training (NCERT), NITI Aayog (Atal Innovation Mission), IIT Bombay, Ministry of Education's Innovation Council to train EMRS teachers to use technology-based tools for teaching. For skill development and vocational education of EMRS students, collaboration have been initiated with CBSE and Ministry of skill development and entrepreneurship.
