#### 383 DR. KANIMOZHI NVN SOMU:

Will the Minister of Communications be pleased to state:

- (a) whether India Post is progressively earning revenue from non-traditional sectors like Ecommerce and payments bank;
- (b) if so, the details thereof;
- (c) the revenue earned by the postal department as a percentage from various value-added services/non-traditional sectors during each of the last three years and the current year;
- (d) the details of future expansion plans proposed by Government in the above sector/services in the State of Tamil Nadu; and
- (e) the Post Office-wise number of postal payment bank accounts in Tamil Nadu?

- (d) Government of India through Department of Posts is providing various value added services/non traditional services viz. banking and health insurance services in collaboration with India Post Payments Bank (IPPB), bill payment services, passport services through Post Office Passport Sewa Kendra (POPSK), Aadhar enrolment and updation services etc in India including the state of Tamil Nadu. The services are expanded to include new areas depending on market needs and customer expectations.
