- (b) State-wise list of the number of registered labourers;**
- (c) the details of financial status of Building and Other Construction Workers Welfare Boards constituted in various States and the number of members whose claims for welfare schemes are pending; and**
- (d) State-wise details of the number of beneficiaries who have been disbursed money under various schemes during the last five years and the amount given to beneficiaries?**

**ANSWER**

**(a) to (d): As per Section 3 of the Building and Other Construction Workers' Welfare Cess Act, 1996, the State Governments are mandated to collect the cess and as per Section 22 of the Building and Other Construction Workers (RE&CS) Act, 1996, the State/UT Governments through State/UT Welfare Boards are empowered and entrusted to implement welfare schemes for Building and Other Construction Workers (BOCW) relating to life and disability cover, health and maternity cover, financial assistance for education of wards, transit housing, skill development, awareness programs, pension etc. Details regarding welfare claims are maintained by State/UT BOCW Welfare Boards. Under Section 60 of BOCW Act, 1996 the Central Government issues instructions to state/UT Governments to ensure proper utilization of the cess fund as per mandate of the Act. State-wise list of number of registered labourers and the details of financial status of Building & Other Construction workers Welfare Boards are given at the Annexure.**
