CLSS UNDER PMAY

NO. 536. SHRI K.R.N. RAJESHKUMAR:

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) whether Government is aware that the Credit Linked Subsidy Scheme (CLSS) is a benefit under the Pradhan Mantri Awas Yojana (PMAY) which focuses on helping the Middle Income Groups, Economically Weaker Sections, and Lower Income Groups in India by bringing down their housing loan EMIs by over ₹ 2,000 per month by offering an interest subsidy;
- (b) if so, the total number of beneficiaries during the last five years, State-wise, particularly in Tamil Nadu;
- (c) whether Government is now considering to scrap this scheme; and
- (d) if so, the details thereof and the reasons therefor?

ANSWER

THE MINISTER OF HOUSING AND URBAN AFFAIRS

(SHRI HARDEEP SINGH PURI)

- (a)Yes, Sir. Government provides interest subsidy on home loans under Credit-Linked Subsidy Scheme (CLSS) vertical of the Pradhan Mantri Awas Yojana Urban (PMAY-U). Under CLSS, there is an interest subsidy of 6.5 % for EWS/ Low Income Group (LIG), 4% for Middle Income Group-I (MIG-I) and 3% for Middle Income Group-II (MIG-II), calculated on housing loan up to ₹6 lakh, ₹9 lakh and ₹12 lakh, respectively, over a loan tenure of 20 years.
- (b) State-wise number of beneficiaries under CLSS vertical ofPMAY-U,including for the State of Tamil Nadu,during the last five years i.e., F.Y.2016-17 to F.Y. 2020-21are at Annexure-I.

(c)&(d)'Land' and 'Colonisation' are State subjects. Ministry of Housing and Urban Affairs has been implementing PMAY-U to provide financial assistance to States/UTs for addressing the housing requirement of eligible urban beneficiaries as per scheme guidelines. CLSS for MIG was effective from 01.01.2017 up to 31.03.2021. CLSS for EWS/LIG along with other three verticals of PMAY-U, i.e. Beneficiary Led Individual house construction/enhancement (BLC), Affordable Housing in Partnership (AHP) and 'Insitu' Slum Redevelopment (ISSR) has become effective from 17.06.2015 and is up to 31.03.2022.
