Establishment of agriculture and rural based small enterprises

584# SHRI RAM CHANDER JANGRA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of the number of agriculture and rural based small enterprises established by Government during the last three years, State-wise;
- (b) whether any new discovery or experiments have been done for better results of Micro, Small and Medium Enterprises during the said period, if so, the details thereof; and
- (c) if not, the measures under consideration to keep up the competition with inexpensive products of China, Japan and other countries?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NARAYAN RANE)

- (a): Prime Minister's Employment Generation Programme (PMEGP) is a major credit-linked subsidy programme implemented by this Ministry, aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and unemployed youth. State-wise number of units set up under PMEGP for the last three years and current year (up to 31.01.2022) is given at Annexure.
- (b) & (c): Ministry of MSME through its institutes like Technology Centres, Mahatma Gandhi Institute for Rural Industrialization, Coir Board, Khadi and Village Industries Commission has undertaken research in developing new technologies and products for the MSME sector in order to make it competitive. These include (i) Solar based wool prespinning machines, (ii) Hank dyeing machine, (iii) Ginning machine, (iv) Peddle operated blunger, (v) Mini Carding machine, (vi) Khadi paint (vii) Tool & Die making, (viii) Prototyping of new products, (ix) Handmade paper, (x)) Bio softened mattress, (xi) Automotive interior mirror cover, (xii) Oxygen enriching wall sheet, etc.
