Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total number of people provided with full 100 days of employment under MGNREGA in the last five years, State-wise;
- (b) the details of the additional fund allocated to all the States to provide 150 days of employment, State-wise;
- (c) the total number of people provided with 150 days of employment since the extension, State-wise; and
- (d) the number of people provided with unemployment allowance in the last five years, State-wise?

ANSWER

(a): State/UT-wise details of households availed 100 days of employment under the Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) during the last five financial years 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 is given at **Annexure-I**.

(b)&(c): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment programme which provide for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work.

In addition to this, there is a provision for additional 50 days of unskilled wage employment in a financial year in drought/natural calamity notified rural areas.

There is no financial allocation is made under this demand driven scheme to States/UTs. Fund release to the States/UTs is a continuous process. Funds are released to the States/UTs on the basis of "agreed to" Labour Budget (LB) and performance of the States/UTs during the financial year. During the current financial year, State Government of Karnataka has been allowed for additional 50 days in notified natural calamity affected area of Karnataka.

State/UT-wise details of households availed 150 days of employment, against the provision of additional 50 days employment per household in a financial year in drought and other natural calamity affected notified areas of States, against the proposal of States under the

Mahatma Gandhi NREGS since the extension of this provision for financial years 2017-18, 2018-19, 2019-20 and 2020-21 is given at **Annexure-II**.

(d): State/UT-wise details of households availed unemployment allowance under the Mahatma Gandhi NREGS during the last five financial years 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 is given at **Annexure-III**.
