MSMEs UNITS SHUTDOWN DURING THE PANDEMIC

1402. SHRI KAMAKHYA PRASAD TASA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether it is a fact that thousands of Micro, Small and Medium Enterprises (MSMEs) units were shut down after the advent of Coronavirus and, if so, the details thereof;
- (b) the total MSMEs units registered in the country, State-wise, as on date;
- (c) whether Government has taken any measures to prevent insolvency among MSMEs and measures to avoid layoffs; and
- (d) if so, the details thereof and, if not, the reasons therefor?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): The adverse impact of Covid-19 pandemic has been felt on the economy including on the MSME sector. The Ministry of MSME on 7th September, 2021 assigned a study to Small Industries Development Bank of India (SIDBI), the terms of reference of which inter-alia included assessment of losses suffered by the MSME sector due to Covid-19 pandemic. The said study was based on the survey conducted by SIDBI taking a random sample pool comprising 1,029 MSMEs spread across 20 States and 2 Union Territories. The report of the study submitted on 27th January, 2022, reveals that 67 percent of the respondent MSMEs were temporarily closed for upto a period of 3 months.
- (b): The total number of MSMEs which have registered on Udyam portal as on 9.03.2022(11.00 AM) and have been classified as micro, small and medium is 75,73,793. The State-wise details are at Annexure.
- (c) & (d): The Government has taken a number of recent initiatives under the Aatma Nirbhar Bharat Abhiyan to mitigate the negative impact of Covid-19 on small businesses in the country and to prevent insolvency among MSMEs and to avoid layoffs. Some of them are:
 - i. Rs. 20,000 crore Subordinate Debt for stressed MSMEs.
 - ii. Rs.3 lakh crores Emergency Credit Line Guarantee Scheme (ECLGS) for Businesses, including MSMEs (which has subsequently been increased to Rs. 5 lakh crore, as announced in Budget 2022-23).
 - iii. Rs. 50,000 crore equity infusion through MSME Self-Reliant India Fund.
 - iv. New Revised criteria of classification of MSMEs.
 - v. New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
 - vi. No global tenders for procurement up to Rs. 200 crores.

An Online Portal, "Champions", has been launched on 01.06.2020 by Hon'ble Prime Minister. This covers many aspects of e-governance including redressal of grievances and handholding of MSMEs.

In addition, measures have been taken by the Reserve Bank of India for restructuring of MSME accounts.
