UTILISATION OF DMF FUNDS

1409: SHRI DEREK O' BRIEN:

Will the Minister of MINES be pleased to State:

- (a) the number of mining affected persons and hectares of mining affected areas identified by District Mineral Foundations (DMFs) in each state;
- (b) the amount collected and amount spent from DMF funds in each State;
- (c) the amount that has been spent on each category of work; and
- (d) the part of this amount that was spent by DMFs for beneficiaries that are not identified as mining affected?

ANSWER

THE MINISTER OF MINES, COAL AND PARLIAMENTARY AFFAIRS (SHRI PRALHAD JOSHI)

(a) to (d): Section 9B of the MMDR Act empowers the State Government to establish District Mineral Foundation in all the Districts affected by mining for the benefit of the people and areas affected by mining activities. As per PMKKKY guidelines issued vide order dated 16.09.2015, affected area has been divided into two categories viz. (i) directly affected area; and (ii) indirectly affected area. Directly affected areas are those areas where direct miningrelated operations such as excavation, mining, blasting, beneficiation and waste disposal (overburdened dumps, tailing ponds, transport corridors etc.), etc. are taken up and indirectly affected areas are those areas where local population is adversely affected on account of economic, social and environmental consequences of mining-related operations. Mining affected people includes directly affected families and displaced families as defined under Section 3 (c) and 3 (k) respectively of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act.

Information on the amount collected and amount spent from DMF funds in each State has been provided in Annexure-I and the information on amount that has been spent on each category of work has been provided in Annexure-II
