2040. SHRI IRANNA KADADI:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the number of pre-matric scholarships which have been provided, State/UT-wise with a particular emphasis on Karnataka;
- (b) the number of post-matric scholarships which have been provided, State/UT-wise with a particular emphasis on Karnataka;
- (c) the number of Merit-cum-means scholarship which have been provided, State/UT- wise with a particular emphasis on Karnataka; and
- (d) the statistics on how these scholarships are spread over different minority groups?

ANSWER THE MINISTER OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

- (a) to (c): The Ministry of Minority Affairs implements three Scholarship Schemes namely Pre-Matric, Post Matric and Merit-cum-Means based Scholarship Schemes for the educational empowerment of the six centrally notified minority communities viz. Buddhist, Christian, Jain, Muslim, Parsi and Sikh. The Scheme-wise and Statewise details (including State of Karnataka) of scholarships sanctioned under these 3 Scholarship Schemes since 2014-15 till 2021-22 is annexed.
- (d): The distribution of Scholarship among the States/Union Territories is made on the basis of population of minorities in the States/Union Territories as per the Census. It was based on Census 2001 up to 2017-18 and thereafter, it is based on Census 2011.
