Will the Minister of PETROLEUM & NATURAL GAS be pleased to refer to the answers to Unstarred Questions 153 and 618 given in the Rajya Sabha on 29th November, 2021 and 7th February, 2022, respectively and to state:

- (a) the reason for variation in the answers;
- (b) the policy in place for payment of Performance Related Pay (PRP) and business expenses;
- (c) whether it is a fact that officers of various Public Sector Undertakings (PSUs) of the Ministry have been paid under the head of 'Business Expenses' during the lockdown 2020; and
- (d) the amount paid to each officer separately?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF PETROLEUM & NATURAL GAS (SHRI RAMESWAR TELI)

(a) Government's response to Question No. 153 for 29.11.2021 brought out the entitlement of Performance Related Pay (PRP) and payment of business expenses to CVO of HPCL on the date of reply.

Government's response to Question No. 618 for 07.02.2022, on the other hand, related to payment of PRP and business expenses to the then senior management including CVO of HPCL, whose entitlements were governed by earlier guidelines, which have been since amended.

Therefore, the responses to Question No. 153 for 29.11.2021 and Question No. 618 for 07.02.2022, addressed different queries.

- (b) Payment of Performance Related Pay (PRP) in oil PSUs is as per extant instructions of Department of Public Enterprises (DPE). PSUs define their policy on business expenses, as per their requirements.
- (c) & (d): Information furnished by oil PSUs is at Annexure.
