- (a) the details of technical and financial support provided by the Ministry under National Rural Health Mission for better and smooth functioning of health services in States;
- (b) the details of funds allocated, sanctioned, released and spent under National Health mission (NHM) in the State of Andhra Pradesh during the last five years, year-wise;
- (c) the details of Physical targets set and achieved during the above period; and
- (d) the details of proposals received in the form of Programme Implementation Plans under NHM during the above period, year wise, and status of the proposals?

(a): The National Health Mission (NHM) envisages achievement of universal access to equitable, affordable & quality health care services that are accountable and responsive to people's needs. NHM encompasses its two Sub-Missions, the National Rural Health Mission (NRHM) and the National Urban Health Mission (NUHM).

Public Health and Hospitals is a State Subject, hence, the responsibility of strengthening public healthcare system lies with the respective State/UT Governments. Under National Health Mission (NHM), Ministry of Health & Family Welfare (MoHFW) provides technical and financial support to States/UTs for strengthening their healthcare systems, based on the proposals submitted by them in their Program Implementation Plans (PIPs), subject to availability of resources. Government of India provides approval for the proposals in the form of Record of Proceedings (RoPs), as per norms & available resources.

The support provided under NHM includes support for engaging of health human resource on contractual basis, National Ambulance Services, Mobile Medical Units, ASHAs,

Infrastructure strengthening, creation of 1,50,000 Ayushman Bharat-Health and Wellness Centres (AB-HWCs) by transforming the existing Sub Centres and Primary Health Centres, 24 x 7 Services and First Referral facilities, Mera Aspataal, Kayakalp Award Scheme, Prime Minister's National Dialysis Programme, National Quality Assurance Standards implementation and related Activities, LaQshya Certification, Rogi Kalyan Samiti, Village Health Sanitation and Nutrition Committees, Biomedical Equipment Maintenance and Management Programme, Free Diagnostics Service Initiative and Free Drugs Service Initiative.

(b): The year-wise details of central release and utilization under National Health Mission (NHM) to the State of Andhra Pradesh during FY 2016-17 to 2020-21 are given at **Annexure-I (A)**.

(c): As reported by the State Government of Andhra Pradesh through NHM-MIS report, the details of physical achievements and progress in Andhra Pradesh under NHM during the year 2017 to 2021 are given at **Annexure-I (B)**.
