**SUSTAINABLE ROOFTOP IMPLEMENTATION FOR SOLAR
TRANSFIGURATION OF INDIA (SRISTI)
SCHEME**

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the total solar power capacity achieved in India under Sustainable Rooftop Implementation for Solar Transfiguration of India (SRISTI) scheme as on date;
- (b) the details of solar power capacity achieved under SRISTI scheme as on date, Statewise;
- (c) total Central Financial Assistance disbursed by Government under the said scheme as on date; and
- (d) the data of the Central Financial Assistance disbursed by the Union Government as on date, State-wise?

ANSWER

(a) to (d) In December 2017, the Ministry of New and Renewable Energy circulated a concept note for stakeholders' consultation on 'Sustainable Rooftop Implementation for Solar Transfiguration of India (SRISTI)' to promote rooftop solar in the country. SRISTI is not the official name of the rooftop solar scheme.

Ministry is implementing phase II of the Grid Connected Rooftop Solar Programme under which subsidy is being provided for rooftop solar (RTS) installation in residential sector. Till 08.03.2022, around 1252 MW RTS capacity has been reported installed in the residential sector and central financial assistance amounting to Rs. 1132.74 crore has been disbursed to various Electricity Distribution Companies/Electricity Departments, under the Programme. State-wise details are attached as **Annexure**.
