WATERWAYS FOUND USEFUL FOR FREIGHT TRANSPORT

Will the Minister of PORTS, SHIPPING AND WATERWAYS be pleased to state:

- (a) the number of waterways which have been found useful for freight transport in the country;
- (b) the number of waterways which are being utilized for transporting goods at present;
- (c) whether it is a fact that most of the waterways selected for freight transport remain unuseful; and
- (d) the funds spent for the development of these waterways during the last three years and the revenue received during the said period, therefrom?

ANSWER

MINISTER OF PORTS, SHIPPING AND WATERWAYS
(SHRI SARBANANDA SONOWAL)

- (a) To promote inland water transport (IWT) in the country, 111 National Waterways (NWs) (including 5 existing and 106 new) were declared under the National Waterways Act, 2016. Based on the outcome of techno-economic feasibility and Detailed Project Reports (DPRs) prepared for NWs, 26 NWs have been found viable for cargo/passenger movement (Details at **Annex.-1**).
- (b) At present, transportation of goods is recorded on 19 NWs out of the above 26 NWs.
- (c) No Sir. Most of the waterways are useful as 19 of the 26 NWs used for freight transport have recorded cargo movement of 83.61 million tones per annum (MTPA) during the year 2020-21 and 96.31 MTPA (till 28.02.2022) during the year 2021-22.
- (d) Funds spent for the development of these waterways during the last three years and the revenue during the said period is detailed at **Annex – 2**.
