Need for completion of Jeypore and Utkela Airports

SHRI MANAS RANJAN MANGARAJ (Odisha): Sir, I would like to draw your attention to the unprecedented delay in completion of two airports in Maoist infested region of Koraput and Kalahandi districts. The airports in Jeypore (Koraput) and Utkela (Kalahandi) were planned along with Jharsuguda Airport under the UDAN scheme way back in 2017, but the work began only in 2020 after a lot of deliberations and persuasions. While the Jharsuguda Airport has become operational and Rourkela has been added to the list of UDAN, people in Koraput and Kalahandi are still awaiting their dreams to be materialized. Despite several inspections and promises thereafter, things are getting delayed for unknown reasons. Both Koraput and Kalahandi are known as the gateway to commercial hubs in the neighbouring States. Whether in terms of business viability or safe communication mode in the wake of Maoist threats, Jeypore and Utkela Airports are very crucial not only for people in the region but also for the entire State. I request the Government to kindly take up this matter on a high

priority and ensure that both Airports become operational as soon as possible in the larger interest of the people.
