#### HEALTH AND WELLNESS CENTRES UNDER AYUSHMAN BHARAT

#### 1048. SHRI HARNATH SINGH YADAV: SHRI VIJAY PAL SINGH TOMAR:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the target set for setting up Health and Wellness Centres(HWCs) under Ayushman Bharat Programme in the country;
- (b) the extent to which the set targets have been achieved during the last three years along with the details thereof, State-wise; and
- (c) the number of HWCs likely to be set up in Uttar Pradesh along with the details thereof, district-wise?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

- (a): As per the budget announcement 2017-18, 1.5 lakh Sub-Health Centres (SHCs) and Primary Health Centres (PHCs) were to be transformed into Ayushman Bharat- Health and Wellness Centres (AB-HWCs) by December, 2022.
- (b): As updated by the States/UTs in AB-HWC portal, a total of 38,595 AB-HWCs operationalized against the target of 40,000 AB-HWC till 31.03.2020, 74,947 AB-HWCs operationalized against the cumulative target of 70,000 AB-HWCs till 31.03.2021 and 1,17,440 AB-HWCs operationalized against the cumulative target of 1,10,000 AB-HWCs till 31.03.2022.

The State wise number of AB-HWCs operationalized against the target for FY 2019-20, FY 2020-21 & FY 2021-22 is enclosed at **Annexure**.

(c): The total number of AB-HWCs to be operationalized in the State of Uttar Pradesh till December 2022 is 19,424. As on 30<sup>th</sup> June, 2022, 13,832 AB-HWCs have been operationalised in Uttar Pradesh. The Ministry of Health and Family Welfare provides technical and financial support to the States/UTs to strengthen their health care systems. The implementation of the scheme along with detailed planning and district-wise target lies under the purview of State Government
