(a) to (c): Ministry of Tourism, promotes India in a holistic manner, including the State of Uttar Pradesh. As part of its ongoing activities, it releases global print, electronic and online media campaigns in important and potential markets overseas, under the "Incredible India" brand – line, to promote various tourism destinations and products of the country, through its scheme of "Domestic Promotion and Publicity including Hospitality" (DPPH) and "Overseas Promotion and Publicity including Market Development Assistance" (OPMD). Promotions of various destinations including Uttar Pradesh are also regularly undertaken through the website (www.incredibleindia.org) and the Social Media handles of the Ministry.

Further, for the development of tourism infrastructure in the country, the Ministry of Tourism under the schemes of "Swadesh Darshan" and "National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive" - PRASHAD provides financial assistance to State Governments/Union Territory (UT) Administrations, including Uttar Pradesh, in consultation with them.
