FUNDS RELEASED BY GOVERNMENT TO SSI

902. SHRI IRANNA KADADI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether Government has released funds for setting up Small Scale Industries (SSI) under its ongoing scheme during the last three years and if so, the total funds released by Government, State/year-wise;
- (b) the total number of SSIs set up in various States during the said period;
- (c) the details of the different units of Micro, Small and Medium Enterprises proposed to be set up in the State of Karnataka including present status thereof; and
- (d) whether Government has allocated land for setting up of all these units and if so, the details thereof, State-wise?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES

(a) & (b): Ministry of MSME, through Khadi and Village Industries Commission (KVIC), is implementing Prime Minister's Employment Generation Programme (PMEGP) for generating self employment opportunities in the country by setting up micro-enterprises in non-farm sector. Under PMEGP, General Category beneficiaries can avail of Margin Money (MM) subsidy of 25 % of the project cost in rural areas and 15% in urban areas. For Special Categories such as SC/ST/OBC/ minorities/ women/ transgender/ ex-serviceman/differently abled/NER/Hill, Border areas and Aspirational districts, etc. the Margin Money subsidy is 35% in rural areas and 25% in urban areas. Maximum project cost for manufacturing sector is Rs.50 lakh and for service sector it is Rs.20 lakh. Loan for setting up of the micro enterprises is provided through the Banks and the eligible Margin Money subsidy is credited in the loan account of the beneficiaries by the Government.

State-wise number of micro enterprises set up under PMEGP and the subsidy (funds) disbursed by the Government during last three years is given at **Annexure**.

(c): Details of the targets fixed for setting up of micro-enterprises under PMEGP in the State of Karnataka during FY 2022-23 and the present status of achievement is as under:
