PROMOTION OF LOCAL TRADITIONAL ARTISANS

- (a) whether Government has taken steps to promote the local traditional artisans and their art;

- (c) whether steps have been taken to promote their art more in the mainstream commerce and market;

ANSWER

THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

- (a) & (b): The Government of India has taken many steps to promote the local traditional artisans and their art. The Office of Development Commissioner (Handicrafts) implements National Handicrafts Development Programme (NHDP) and Comprehensive Handicrafts Cluster Development Scheme (CHCDS) for development of handicrafts.
- (c) to (e): Government implements various schemes and programmes for promotion of art and crafts. One specific scheme namely Marketing Support and Services scheme has exclusively been crafted to promote their art and crafts more in the mainstream commerce and market. It provides Grantin-aid to eligible implementing agencies for organizing various domestic and international marketing events for the benefit of handicrafts artisans. They have also been on boarded on Government e-Marketplace (GeM) Portal which provides marketing platform for selling handicraft products directly. The details of the domestic marketing events organized during last 3 years is given in annexure- I.
