Funds for the construction of buildings of Central Universities in Bihar

Will the Minister of *EDUCATION* be pleased to state:

- (a) funds sanctioned, released and spent for construction of buildings of Central Universities situated in Motihari and Gaya;
- (b) details of the land that was to be provided by the State Government of Bihar and the land that has been made available in Gaya and Motihari so far;
- (c) number of sanctioned and in-position academic and non-academic posts in Central Universities of Gaya and Motihari;
- (d) the departments which are functional in both Central Universities and the departments proposed to be started this year; and
- (e) the departments which are being run in rented accommodation outside the premises at both the Universities?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUBHAS SARKAR)

(a) There are two Central Universities in Bihar, one at Motihari and the other one at Gaya. Funds sanctioned, released and spent for construction of building for Central University of South Bihar (CUSB), Gaya for the Financial Years from 2014-15 to 2021-22 are given below:

Mahatma Gandhi Central University (MGCU), Motihari is being run in the transit campus and land has not been allotted completely. Therefore, no fund for construction of building has been sanctioned to MGCU.

- (b) Out of proposed 301.97 acres of land to be transferred by Government of Bihar to MGCU, 32.18 acres of land in the first phase and 102.39 acres of land in second phase, have been transferred. However, mutation process of only 28.45 acres has been completed. Three hundred acres of Defence Land located at Gaya was made available to CUSB.
- (c) Details of sanctioned and in-position academic and non-academic posts are as follows: -

There is no proposal to start new Department in respect of both the Universities.

(e) In CUSB, all the Departments are being run in the existing building of CUSB. Out of 20 functional Departments in MGCU, 12 are currently being run in rented accommodation and 8 are being run in the existing building.
