FOOD ADULTERATION

1872. SHRI HARBHAJAN SINGH:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Government has any proposal for more stringent legal action against those involved in food adulteration;
- (b) if so, the details thereof; and
- (c) the number of persons booked and convicted, State-wise, relating to crimes of Food adulteration during the last three years?

(a) to (c): Food Safety and Standards Act, 2006 has a stringent penalty of imprisonment for a term not less than seven years but which may be extended to imprisonment for life and also with fine of not less than ten lakh rupees for manufacture, storage, sale, distribution or import of unsafe food for human consumption which results in death.

The implementation and enforcement of Food Safety and Standards (FSS) Act 2006, Rules and Regulations primarily lies with the State/UT Governments. Regular surveillance, monitoring, inspection and sampling of food products are carried out by Food Safety Officers of States/UTs and penal action is taken against the defaulting Food Business Operators (FBOs) as per the provisions of FSS Act, 2006, Rules and Regulations.

As per information received from States/UTs, details of food samples analyzed and action taken thereon during the last three years i.e. 2018-19, 2019-2020 and 2020-2021, for which information is available at **Annexure-I and II**.
