State/UT-wise details of pending liabilities for material components under Mahatma Gandhi NREGS in the financial year 2022-23 (as on 27.07.2022) are given at **Annexure-II.** 

In the current financial year 2022-23, the budget provision at Budget Estimate stage is Rs. 73,000 crore under Mahatma Gandhi NREGS.

Fund release to States/UTs is a continuous process and Central Government is committed in making funds available to States/UTs for the implementation of the Scheme. The Ministry seeks additional funds under Mahatma Gandhi NREGS from the Ministry of Finance as and when required for meeting the demand for work on the ground.
