GENERATION OF SOLAR POWER IN THE COUNTRY

1904. SHRI HARNATH SINGH YADAV SHRI VIJAY PAL SINGH TOMAR

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether Government has achieved the targets set for the generation of solar power in the country;
- (b) if so, the details thereof along with the quantum of solar power generated in the country during each of the last three years and the current year, State/UT-wise;
- (c) the funds provided by Government for generation and creation of additional capacity of solar power in the country during the said period, State/UT-wise; and
- (d) the other steps taken/being taken by Government for promoting the generation and use of solar power in the country?

ANSWER

(a)&(b) The Government had set a target for setting up of 100 GW solar power capacity by 2022 in the country. Against this, a capacity of 123.11 GW has either been commissioned or is in the pipeline. The details are as under:

State/UT wise details of solar power generated during each of the last three years and the current year are given at **Annexure-I.**

- (c) State/UT-wise details of funds released under various solar schemes of Ministry of New and Renewable Energy (MNRE) during the last three years and the current year are given at **Annexure-II.**
- (d) The Government has taken several steps to promote Renewable Energy including solar energy in the country. These include :
- Permitting Foreign Direct Investment (FDI) up to 100 percent under the automatic route,
- Waiver of Inter State Transmission System (ISTS) charges for inter-state sale of solar and wind power for projects to be commissioned by 30th June 2025,

- Declaration of trajectory for Renewable Purchase Obligation (RPO) up to the year 2029-30,
- Setting up of Ultra Mega Renewable Energy Parks to provide land and transmission to RE developers on a plug and play basis,
- Schemes such as Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyan (PM-KUSUM), Solar Rooftop Phase II, 12000 MW CPSU Scheme Phase II, etc,
- Laying of new transmission lines and creating new sub-station capacity under the Green Energy Corridor Scheme for evacuation of renewable power,
- Setting up of Project Development Cell for attracting and facilitating investments,
- Standard Bidding Guidelines for tariff based competitive bidding process for procurement of Power from Grid Connected Solar PV and Wind Projects.
- Government has issued orders that power shall be dispatched against Letter of Credit (LC) or advance payment to ensure timely payment by distribution licensees to RE generators.
