### **OBJECTIVES AND STATUS OF PMKVY**

#### #2041 SHRI VINAY DINU TENDULKAR:

# Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) the objectives of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) and the current status of its implementation;
- (b) the number of youth who have been provided employment under this scheme so far and the State-wise/Union Territory-wise details of targets set under the said scheme including the details of potential beneficiaries who have established self-employment, the amount allocated and the amount spent so far;
- (c) the number of centres set up in Goa under this scheme to train different sections of people including workers who gave up studies in between and also untrained people; and
- (d) if so, the details thereof?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

- (a) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) is implementing its flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) with an objective to impart short duration skill development training and certification to youth and to make them employable for better livelihood across the country. Since inception, PMKVY has been launched in three phases i.e., PMKVY 1.0 (2015-16), PMKVY 2.0 (2016-20) and PMKVY 3.0 (2020-22). Since inception, till 30.06.2022, 1.36 crore candidates have been benefited from the PMKVY across the country.
- (b) PMKVY has two training components, namely, Short Term Training (STT) and Recognition of Prior Learning (RPL). Under PMKYV, placement opportunities are being provided to STT certified candidates, while RPL is not linked with placements as it recognizes the existing skills of candidates. Under PMKVY-STT, 70.75 Lakh candidates have been trained; out of which 24.16 lakh candidates have been provided with the placement including 2.95 lakh self employed candidates in various sectors across the country. The State-wise details are given at **Annexure- I.** The phase-wise targets and candidates benefited under PMKVY since inception, as on 30.06.2022, are given below:

The PMKVY (except PMKVY 1.0 (2015-16)) has two components, namely, Central component being implemented through National Skill Development Corporation (NSDC), and State component being implemented through State Skill Development Mission of the State/UT. Under Central component of PMKVY, there is no provision of State-wise funds allocation. Since inception of the PMKVY, as on 30.06.2022, an amount of Rs. 8,590.29 crore has been disbursed to implementing agency, i.e., NSDC towards the implementation of the scheme. Under State component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation of scheme through State Skill Development Missions (SSDMs). The State-wise funds allocated, disbursed and utilized by the State under PMKVY 2.0 and PMKVY 3.0, as on 30.06.2022, is given at **Annexure II.** 

(c) & (d) Under PMKVY, short term training is being implemented in accredited and affiliated training centres across the country. As on 30.06.2022, short term training under PMKVY has been imparted through 49 training centres including Pradhan Mantri Kaushal Kendra in the State of Goa. MSDE promotes establishment of model training centres in every district of the country known as Pradhan Mantri Kaushal Kendra (PMKK). As on 30.06.2022, 1 PMKK has been established in the State of Goa.
