NEW TOURIST SPOTS IN PUNJAB

207 DR. ASHOK KUMAR MITTAL:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has identified new tourist spots in the country during the last three years for their expansion, beautification and upgradation for development and promotion of tourism;
- (b) if so, the details thereof along with the locations where new tourist spots have been developed during last three years and the amount spent thereon, State/UT-wise including Punjab;
- (c) steps taken/being taken by Government to improve connectivity and other facilities at the existing and proposed new tourist destinations in Punjab; and
- (d) whether Government proposes to develop these new places along with the existing tourist places to promote tourism in the country?

ANSWER

STATEMENT IN REPLY TO PARTS (a) TO (d) OF RAJYA SABHA STARRED QUESTION NO.207 ANSWERED ON 04.08.2022 REGARDING NEW TOURIST SPOTS IN PUNJAB.

(a) to (d): Identification and opening of new tourist spots is primarily the responsibility of the State Governments/Union Territory Administrations. However, the Ministry of Tourism has provided financial assistance to State Governments/Union Territory Administrations/Central Agencies including the State of Punjab under the ‘Swadesh Darshan’, ‘National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)’ and ‘Assistance to Central Agencies for Tourism Infrastructure Development’ Schemes for the development of tourism related infrastructure and facilities to provide an enriching tourism experience to visitors. In addition, financial assistance has been provided to the States/UTs including the State of Punjab for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

The Ministry of Tourism promotes all tourist spots in the country including lesser known destinations through its media campaigns, websites, road shows, social media promotions and Dekho Apna Desh initiative to attract more tourists and generate employment.

The details of the projects sanctioned under the ‘Swadesh Darshan’, ‘PRASHAD’ & ‘Assistance to Central Agencies for Tourism Infrastructure Development’ Schemes as well as financial assistance provided for organizing fairs/festivals and tourism related events under DPPH Scheme to the States/UTs including Punjab is **annexed**.

The Ministry of Tourism is giving due focus on developing last mile connectivity and improving accessibility to and within India. The ‘National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive’ (PRASHAD) and Swadesh Darshan Schemes aim at infrastructure development which includes development/upgradation of destination entry points viz. passenger terminals (of road, rail, and water transport), basic conveniences like tourism Information/Interpretation Centers, equipment for tourism activities, souvenir shops/cafeteria, ATM/Money exchange counters, improvement in last mile connectivity etc. to attract maximum tourists for bringing the socio-economic benefits from tourism to the local communities.

The Regional Connectivity Scheme – Ude Desh Ka Aam Nagrik (RCS-UDAN) was launched by the Ministry of Civil Aviation to make air travel more affordable for the common public of the country including Punjab. Ministry of Tourism has been supporting and giving its recommendations for inclusion of tourism routes and improving the air connectivity. Ministry of Tourism has been supporting the RCS-UDAN 3.0 for the 46 identified tourism routes, out of which 31 are operational. For improving air connectivity to Punjab, 6 tourism routes are operational from Amritsar to Jaipur, Kolkata and Patna.

Ministry of Tourism (MoT) has been seeking support of Ministry of Road Transport & Highways (MoRTH) to improve the road connectivity to the important tourist destinations. In this regard, Ministry of Tourism in consultation with State Governments and UT Administrations had prepared two lists i.e. first list of 50 destinations and second list of 114 destinations and subsequently shared these two lists with MoRTH.

Ministry of Tourism has also taken up the matter with Ministry of Railways for better rail connectivity. Ministry of Railways has informed that ‘Bharat Darshan Trains’ run on theme based tourism circuits such as Ramayana Circuit, Jyotirlinga Circuit, Buddhist Circuits etc. Further, Railways have also informed that they have launched ‘Bharat Gaurav Trains’ (Theme based Tourist Circuit Trains) to showcase India’s rich cultural heritage and magnificent historical places. Apart from this, Ministry of Tourism under “Assistance to Central Agencies for Tourism Infrastructure Development” Scheme, joined hands with Ministry of Railways for development of tourist infrastructure amenities at 22 identified railway stations on 50:50 cost sharing basis. Amritsar Railway Station is also included in the list of these 22 Railway Stations.
