Will the Minister of FINANCE be pleased to state:

- (a) whether Government has released the instalment of Post Devolution Revenue Deficit (PDRD) grant to some States as per the recommendations of the 15th Finance Commission, if so the details thereof; State-wise; and
- (b) the pending grant to be released to each State as on date and by when will it be released?

ANSWER

MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

- (a) Yes Sir. Fifteenth Finance Commission has inter-alia recommended a total Post Devolution Revenue Deficit (PDRD) grant of Rs. 2,94,514 crore for its award period 2021-22 to 2025-26. Based on the year-wise allocation to the recommended States, so far Rs. 1,47,185.67 crore has been released in equated monthly installment basis to the recommended States from April, 2021 to July, 2022 as per State-wise and Year-wise details given in the Annexure.
