- (b) whether wheat stock is set to fall to its lowest level since 2016-17, if so, reasons therefor and the steps taken to increase wheat stock;
- (c) whether wheat stock is sufficient for distribution under PDS and for emergency situation;
- (d) whether Government is planning to replace wheat with rice provided under Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY); and
- (e) if so, details thereof, if not, reasons therefor?

(b) and (c): The Central Pool stock of wheat as on 1<sup>st</sup> of July 2022 is well above the stocking norms. As on 1<sup>st</sup> of July, 2022, FCI and State Government agencies have 285.10 LMT of wheat stock under Central Pool against the stocking norms of 275. 80 LMT. It is expected that even after meeting out the requirement of PMGKAY (upto Sept.2022) and PDS, the projected wheat stock as on 01.04.2023 would be 134 LMT against the stocking norms of 74.6 LMT.

(d) & (e): In order to ensure management of foodgrain stocks as per norms, to position rice stock for distribution of fortified rice, to ease the pressure on the logistics and in consultation with States/UTs, under PMGKAY (VI) allocation of rice and wheat for 11 States/UTs has been revised for May to September, 2022, in favour of rice while maintaining the total allocation made initially in March, 2022
