Intensive Aquaculture in Ponds and Tanks

2348. Shri Masthan Rao Beeda:

Will the Minister of **Fisheries, Animal Husbandry and Dairying** be pleased to state :

- (a) whether Government has promoted scheme for Intensive Aquaculture of Ponds and Tanks in Andhra Pradesh;
- (b) if so, the district-wise details of activities and funds dispersed under the scheme during the last three financial years and the current financial year thereof and if not, the reasons therefor;
- (c) whether Government has taken steps to promote development of fisheries in the reservoirs of Andhra Pradesh; and
- (d) if so, the district-wise details of activities and funds dispersed for the promotion of reservoir fisheries during the last three years and the current year thereof, if not, the reasons therefor?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(SHRI PARSHOTTAM RUPALA)

(a) and (b): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying is implementing a flagship scheme “Pradhan Mantri Matsya Sampada Yojana (PMMSY): A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India” with an investment of Rs. 20050 crore with effect from the financial year 2020-21 in all the States/UTs including Andhra Pradesh. Under this scheme, the Department of Fisheries, Government of India during the financial years 2020-21 and 2021-22 has accorded approval to the fisheries development proposals of Government of Andhra Pradesh at a total cost of Rs.774.36 crore with central share of Rs. 244.70 crore during financial year 2020-21 and 2021- 22 for development of fisheries and aquaculture in the State. The activities approved *inter-alia* include establishment of fish seed hatcheries, creation of infrastructure for intensive fish culture such as fish ponds with inputs including aerators, fish seed rearing ponds, Bio-floc ponds and tanks, Re-circulatory Aquaculture System (RAS) etc for Intensive Aquaculture in the State of Andhra Pradesh. As reported by the Government of Andhra Pradesh, the district-wise details of activities and funds dispersed under the scheme during the last three financial years and the current financial year is furnished at Annexure-I.

(c) and (d): The PMMSY *inter-alia* provides financial assistance for taking up cage culture and Fingerling stocking in inland water bodies (Reservoirs). The Department of Fisheries, Government of India during the last two years has approved to Government of Andhra Pradesh for stocking of fingerling in 131400 ha and 300 units of cages sanctioned for installation in the reservoirs under the integrated development of Reservoirs in the State at a total cost of Rs. 48.42 crore. Further, the district-wise details of activities and funds disbursed for the promotion of reservoir development for fisheries in Andhra Pradesh during the last three years as reported by the Government of Andhra Pradesh is given in Annexure-II.
