Benefits of PMMSY in Telangana

2354. Dr. K. Laxman:

Will the Minister of **Fisheries, Animal Husbandry and Dairying** be pleased to state:

- (a) whether Government of Telangana has availed the benefits of the schemes like Pradhan Mantri Matsya Sampada Yojana (PMMSY) etc, if so, the details thereof along with the farmers engaged in fisheries who have availed these benefits and the amount of assistance provided in this regard since its inception, district-wise;
- (b) if not, the reasons therefor; and
- (c) the details of fish production during the said period and the difference noticed therein after introduction of these schemes?

ANSWER

(a) and (b): Yes Sir. The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying is implementing the flagship scheme Pradhan Mantri Matsya Sampada Yojana with total investment of Rs. 20,050 crore for a period of 5 years from financial year 2020-21 to 2024-25 in all States/Union Territories including Telangana State. During 2020-21 and 2021-22, the Department of Fisheries has accorded approval of project proposals to Government of Telangana at a total cost of Rs. 147.20 Crore with central share of Rs. 41.51 Crore and released the central share of Rs. 52.13 crore under PMMSY. As reported by Government of Telangana, a total 93203 beneficiaries have availed benefits under the said scheme during the year 2020-21 and 2021-22 respectively. District wise assistance provided to the intended beneficiaries are at Annexure-I.

(c): The fish production during the implementation of Pradhan Mantri Matsya Sampada Yojana (PMMSY) has shown an increasing trend in the State of Telangana and it has increased from 3.00 Lakh tonne in 2019-20 to 3.90 Lakh tonne in 2021-22.
