- (a) whether it is a fact that the repair work of LIG flats allotted by DDA under the 2010 housing scheme has not been done on time due to which the allottees are facing many problems;
- (b) the list of works received by the housing societies, area-wise; and
- (c) the present status of repair work of LIG flats allotted by DDA under the 2010 housing scheme, area-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) & (b): No Sir. Delhi Development Authority (DDA) has informed that with effect from Housing Scheme 2010, the pre-declared maintenance activities are being undertaken by DDA in a timely manner. The remaining maintenance activities are to be undertaken by the Residential Welfare Associations. List of such pre-declared maintenance activities under the purview of DDA are at Annexure-A.
- (c): DDA has informed that execution of pre-declared maintenance activities as per Housing Scheme 2010 is a continuous process and is carried out as per site conditions. The area-wise present status, of pre-declared maintenance activities, is as per Annexure-B.
