2236. SHRI A. A. RAHIM:

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:-

- (a) funds allocated to the Nehru Yuva Kendra during the last five years, State-wise thereof;
- (b) funds spent by the Nehru Yuva Kendra during the last five years, State-wise; and
- (c) whether the Nehru Yuva Kendra funds programmes are conducted by other organizations including cultural organisations, if so, the details of the same including the list of such organisations for which funds have been given?

(a) & (b) Nehru Yuva Kendra Sangathan is an Autonomous body under the administrative control of the Ministry of Youth Affairs and Sports. Ministry releases funds to NYKS Headquarters in Delhi which further allocates funds to its State Offices. State wise funds allocated by NYKS Hqrs and expenditure incurred during last five years, under NYKS is at Annexure.

(c) Nehru Yuva Kendra Sangathan does not release funds to other organizations including cultural organization for conduct of its programmes.
