Ministry of Tourism promotes the tourism destinations of the country, including (a): Kumbakonam, in a holistic manner. The promotions are carried out under the schemes of "Domestic Promotion and Publicity including Hospitality" (DPPH) and "Overseas Promotion & Publicity including Market Development Assistance" (OPMD) in the domestic and important global markets. Promotions are also carried out under different themes including adventure spiritual. wellness and tourism heritage. through the web-site www.incredibleindia.org and through the social media handles of the Ministry.

Further, the Ministry under its Schemes of "Swadesh Darshan" and PRASHAD also provides financial assistance for the development of tourism infrastructure to State Governments/Union Territory (UT) Administrations, at identified sites, in consultation with them. The projects under these Schemes are identified for development in consultation with the State Governments/UTs and are sanctioned subject to availability of funds, submission of suitable detailed project reports, adherence to scheme guidelines, utilization of funds released earlier etc.
