(a) & (b): The National Health Authority (NHA) has launched a new version of Health Benefit Packages (HBPs) 2022 under Ayushman Bharat Pradhan Mantri - Jan Arogya Yojana on 06th April, 2022. HBPs 2022 consist of 1,949 procedures including secondary, tertiary and palliative care across 27 specialties. Details thereof are available under the following link:
