Production of organic fertilizers

1784. SHRI S. KALYANASUNDARAM:

Will the Minister of **CHEMICALS & FERTILIZERS** be pleased to state:

- (a) the amount of organic fertilisers produced, procured and disbursed, State-wise;
- (b) the steps taken to reduce dependency on chemical fertilisers and the details thereof;
- (c) the steps taken to promote the usage of organic natural fertilisers and the details thereof; and
- (d) the measures implemented to create awareness about natural fertilizers amongst farmers ?

ANSWER

(a): The State-wise production of organic fertilizers during the year 2020-21 is at **Annexure-I**. No data on sale of organic fertilizers is available with National Centre for Organic Farming (NCOF).

(b) to (d): To reduce dependency on chemical fertilizers, Government has been promoting organic farming through dedicated schemes of Paramparagat Krishi Vikas Yojana (PKVY) and Mission Organic Value Chain Development for North Eastern Region (MOVCDNER) since 2015-16.

PKVY is implemented in all the States and Union Territories across the country to promote organic farming in cluster mode. Under the scheme farmers are provided financial assistance of Rs 50000/ha for 3 years in which, Rs 31000/ ha / 3 years is provided directly to farmers through Direct Benefit Transfer (DBT) for organic inputs such as seeds, bio fertilizers, bio-pesticides, organic manure, compost/vermi-compost, botanical extracts etc.

MOVCDNER is implemented in all the North Eastern States for promotion of certified organic production, in which, organic farmers are supported to develop their value chain from organic production to processing and marketing etc. through Farmer Producer Organization (FPO) formation. Under the scheme a sum of Rs. 46,575/ha for 3years are provided for creation of FPO, support to farmers for organic inputs, quality seeds/ planting material and training, hand holding and certification. Besides, financial assistance is also provided as subsidy to FPOs and Private entrepreneurs

The Indian Council of Agriculture Research (ICAR) imparts trainings, organises front-line demonstrations, awareness programs etc. to educate farmers on all these aspects. Assistance is provided @Rs. 7500 for training and handholding under PKVY scheme whereas Rs. 10,000/ha/3years is provided for hands on training on organic farming and certification to the farmers under MOVCDNER scheme.
