ANSWER

MINISTER of AGRICULTURE AND FARMERS WELFARE (SHRI NARENDRA SINGH TOMAR)

(a): The Commission for Agricultural Costs and Prices (CACP) is an attached office of the Ministry of Agriculture and Farmers Welfare. The Commission comprises a Chairman, Member Secretary, one Member (Official) and two Members (Non-Official). CACP is not a tenured-based Commission.

The term of Chairman and Member Secretary is five years and of Member (Official) and Member (Non-Official) is three years.

- (b) & (c): As on date, two posts of Member (Non-Official) are vacant. The Ministry is in the process of filling up of these vacant posts.
- (d): CACP conducted several meetings with representatives of various organizations/stakeholders to finalize the Copra Price Policy, Jute Price Policy, Kharif Price Policy, Rabi Price Policy and Sugarcane Price Policy, as per the details given at Annexure.
