ASSESSMENT OF SOLAR ENERGY GENERATION

298#. SHRI NEERAJ DANGI

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether any assessment has been done by Government in the country about solar energy generation, if so, the details thereof;
- (b) the details of the amount allocated and utilised for solar energy development in the country during the last three years, State-wise; and
- (c) whether Government is aware about the hurdles being faced in the field of solar energy, if so, the details thereof?

ANSWER

THE MINISTER OF NEW & RENEWABLE ENERGY AND POWER

(SHRI R.K. SINGH)

- (a) Yes, Sir. The National Institute of Solar Energy, an Autonomous Institute under aegis of this Ministry has assessed the solar energy potential in the country as 750 GW.
- (b) The State-wise details of financial assistance provided under solar energy programmes of MNRE during the last three years are given at **Annexure**.
- (c) The major challenges in implementation of solar energy projects inter-alia involve following:
 - acquisition of clear land,
 - mismatch in timelines between solar projects and power evacuation infrastructure;
 - environmental issues like the Great Indian Bustard (GIB) issue in Rajasthan and Gujarat;
 - regulatory challenges in States (example- Andhra Pradesh, Gujarat) like non-approval in time of solar tariff by SERCs;
 - Deceleration of pace of implementation of solar projects to a considerable extent due to COVID pandemic.
