- (c) the plans, if any, to define and evaluate green bonds in domestic context; and
- (d) the plans, if any, to develop a long term climate investment framework that combines different financial sources?

(b) to (d): In keeping with the ambition to significantly reduce the carbon intensity of the economy, the Union Budget 2022-23 announced the issue of Sovereign Green Bonds for mobilizing resources for green infrastructure. The issuance of Sovereign Green Bonds will help the Government of India (GoI) in tapping the requisite finance from potential investors for deployment in public sector projects aimed at reducing the carbon intensity of the economy. This involves the preparation of a framework for Sovereign Green Bonds issuance in line with international best practices while keeping in mind the domestic priorities of India, selecting appropriate public sector projects, setting up of an institutional mechanism and lastly floating of the bonds. As on date, no sovereign green bond has been issued by the Government of India.
