TOILET FACILITIES ON NATIONAL HIGHWAYS ACROSS THE COUNTRY

417. SHRI SUJEET KUMAR:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the State-wise number of toilet facilities on National Highways across the country;
- (b) the number of Way Side Amenities (WSA) that have been developed by Government and the budgetary allocation toward the scheme for the last five years;
- (c) whether the scheme has been poor in its implementation due to lack of bidding interest, if not, the reasons for setback in the scheme; and
- (d) whether the Ministry has an audit mechanism to monitor the maintenance of the quality of such facilities and the progress of the scheme, if so, the details thereof?

ANSWER

- (a) The details are enclosed as Annexure-I.
- (b) Total 14 Nos. of WSA sites have been operationalized under Public-Private Partnership model, where Authority has leased the land parcels to private entity towards operationalization of the facility. The details of operational WSA facilities are appended in Annexure-II.
- (c) Ministry has now issued the policy circular no. RW/NH-33044/14/2003-S&R(R)-Pt. dated 11th February. 2021. Till date total 118 WSA sites have been awarded.
- (d) The Authority has formulated a review mechanism towards monitoring the maintenance of the quality of WSA facilities. Consultants are being engaged at regional level for effective monitoring of sites. Regular review meetings are organized in office of Project Director (PD), Project Implementation Unit (PIU) at the ground level and further reviewed at Regional/Headquarter level.
