#### DDU-GKY IN GUJARAT

#### 425 SHRI RAMBHAI HARJIBHAI MOKARIYA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) has been implemented in Gujarat by the Central Government, if so, the details thereof;
- (b) the district-wise number of the centres functioning in Gujarat under the said scheme; and
- (c) the details of the institutions operating these centres and the quantum of funds allocated in this regard?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) Yes Sir, the Deen Dayal Upadhyay-Grameen Kaushal Yojana (DDU-GKY) is being implemented in Gujarat since 2014. It is a placement linked skill development program for rural poor youth in the age group of 15-35 years. DDU-GKY guidelines provide for earmarking 50% of the funds for SCs and STs and 15% for minorities. Further, one third beneficiaries of the respective categories under the scheme should be women.

DDU-GKY follows a 3-tier implementation architecture for implementation. National level is responsible for policy, funding of central share and technical support, while State Rural Livelihood Missions (SRLMs)/ State Skills Missions are responsible for funding of State share, implementation and monitoring controls. Project Implementing Agencies (PIAs), which are mostly private training partners, are responsible for mobilization, training and placements.
