Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) details of connectivity projects and allocations made for Punjab under the Pradhan Mantri Gram Sadak Yojana during past three years;
- (b) the details on number of works cleared, new connectivity works, upgradation works, and completed road works in the State of Punjab;
- (c) what is the completed length of roads constructed under the scheme in Punjab, yearwise details thereof; and
- (d) the details of in-progress road works in Punjab under the scheme?

- (a) The details of the roads sanctioned, completed and funds released to the State of Punjab during the last three years under various interventions of Pradhan Mantri Gram Sadak Yojana (PMGSY) are given below:-
