- (a) whether Government has allowed new Mega Food Parks (MFPs) to some States and private firms for the development and promotion of food processing sector in the State of Karnataka, thereby creating employment opportunities;
- (b) if so, the details and the present status thereof;
- (c) whether Government has set any target to develop basic infrastructure of MFPs across the country, if so, the details thereof; and
- (d) the steps taken/proposed to be taken by Government in this regard?

STATEMENT REFERRED TO IN REPLY TO PART (a) TO (d) OF THE RAJYA SABHA STARRED QUESTION NO.73 FOR ANSWER ON 22ND JULY, 2022 REGARDING "MEGA FOOD PARKS".

- (a) & (b): A total of 41 Mega Food Parks approved by the Ministry of Food Processing Industries (MoFPI) are operational/under implementation and these have been approved for State Government entities as well as to private firms. Two Mega Food Parks have been approved in the State of Karnataka (one each in districts of Tumkur and Mandya). List of these 41 Mega Food Parks in 25 different States/Union Territories, including in the State of Karnataka, is at **Annexure**.
- (c) & (d): Mega Food Park Scheme (MFPS) were conceived to create modern infrastructure for the food processing sector along the value chain from farm to market. and was demand driven. The scheme has been discontinued in the 15th Finance Commission cycle.
