GROWTH OF FMCG COMPANIES

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether the Fast-Moving Consumer Goods (FMCG) companies have registered huge growth during the last three years and the current year;
- (b) whether there is an increase of export of FMCG products and if so, the details thereof and the quantum of exports registered during each of the last three years and the current year, year-wise;
- (c) the contribution of FMCG in the overall economic development of the country; and
- (d) the measures undertaken by Government to monitor the FMCG companies which are producing sub-standard products along with companies that have been booked in the last three years, year-wise?

(a) : Department of Consumer Affairs does not maintain specific data regarding Fast-Moving Consumer Goods (FMCG).

(b) : The details of last year, during the last three financial years and current financial year are given at **Annexure**.

(c) : The question does not arise in view of (a) above.

(d) : There is a provision, inter-alia, of three tier quasi-judicial mechanism under the Consumer Protection Act, 2019, District Consumer Disputes Redressal Commission, State Consumer Disputes Redressal Commission and National Consumer Disputes Redressal Commission to adjudicate the consumer complaints which include sub-standard products, deficiency in services and unfair trade practices etc.
