### 729 SHRI JAWHAR SIRCAR:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the food crops currently notified for Minimum Support Price (MSP) and which were actually procured in the last six major seasons;
- (b) the percentage of crops that were actually procured under MSP vis-a-vis the total production of these crops in the last six major seasons;
- (c) the season-wise expenditure for MSP procurements and the cost of transportation and storage per season; and
- (d) whether extension of MSP is considered feasible and affordable?

(a) and (b): Ministry of Agriculture & Farmers Welfare, Government of India fixes Minimum Support Prices (MSPs) for foodgrains namely wheat, paddy, maize, jowar, bajra, ragi, barley, arhar (tur), moong, urad, gram and masur.

The percentage of these crops that were actually procured under MSP vis-à-vis the total production in the last six major seasons is at **Annexure-I**

(d): Ministry of Agriculture & Farmers Welfare, Government of India fixes Minimum Support Prices (MSPs) for 22 mandated agricultural crops viz wheat, paddy, maize, jowar, bajra, ragi, barley, arhar (tur), moong, urad, gram, masur, groundnut, rapeseed/mustard, soyabean, sesamum, sunflower seed, safflower, nigerseed, cotton, jute and copra on the basis of the recommendations of the Commission for Agricultural Costs and Prices (CACP), after considering the views of State Governments and Central Ministries/Departments concerned and other relevant factors. In addition, MSP for toria and de-husked coconut is also fixed on the basis of MSPs of rapeseed/mustard and copra respectively.
