NO. 540. SHRI AJIT KUMAR BHUYAN:

Will the Minister of *Housing and Urban Affairs* be pleased to state:

- (a) the details of the work/schemes sanctioned till now for Guwahati city which was declared and taken up as smart city;
- (b) the detailed list of works and corresponding value of work extended till now including names of executing firms/agencies;
- (c) whether Government is required to publish press release or advertisement in local print media about the work done or in hand against Smart City Project of Guwahati; and
- (d) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) & (b): Government of India launched Smart Cities Mission (SCM) on 25 June 2015. 100 Smart Cities have been selected through 4 rounds of competition from January 2016 to June 2018. The city of Guwahati was selected for development as a Smart City in Round-1 of the Smart Cities Challenge. The list of projects being implemented by the Guwahati Smart City including their cost and present status is given in Annexure-I. The details of executing firms/agencies are not maintained by SCM.
- (c) & (d): Guwahati Smart City has informed that they issue press releases as per need and publish advertisements of completed projects at the time of their launch/inauguration.
