### RAJYA SABHA UNSTARRED QUESTION NO. 868

TO BE ANSWERED ON THE  $14^{\text{TH}}$  DECEMBER, 2022/ AGRAHAYANA 23, 1944 (SAKA)

SMUGGLING OF COUNTERFEIT CURRENCY FROM ACROSS BORDER 868 SHRI RAGHAV CHADHA:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that counterfeit currency notes are being smuggled from across the border on a large scale;
- (b) if so, the details thereof and the quantum of fake currency seized at the borders in denominations of 2000 and 500 by the security forces so far;
- (c) whether it is a fact that circulation of fake currency is rampant in the country;
- (d) the total estimated fake currency in circulation in the country; and
- (e) the measures taken to check circulation and smuggling of fake currency in the country?

#### **ANSWER**

# MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NITYANAND RAI)

(a) to (d): The National Crime Records Bureau (NCRB) is the nodal agency, which compiles the data on crimes including the fake currency notes, as reported to it by the States and the Union Territories, and publishes the same in its annual publication 'Crime in India'. The published reports are available till the year 2021. The details of fake currencies seized during the last three years i.e. 2019 to 2021, including border areas, by the security forces, are as per the Annexure. However, the data does not reveal any particular pattern about circulation of Fake Indian Currency Notes (FICN).

- (e): To counter the menace of fake currency, Intelligence and Security Agencies of Centre and State Governments keep a close watch on the elements involved in the circulation and smuggling of fake currency in the country and take action on any reported violation of law. The Government has taken various measures, which inter-alia, include:
  - i) The production or smuggling or circulation of High Quality

    Fake Indian Currency has been made a terrorist act under the

    Unlawful Activities (Prevention) Act, 1967.
  - has been formed by the Ministry of Home Affairs to share intelligence/information among the security agencies of the states/centre to counter the problem of circulation of fake currency notes in the country.
  - iii) A Terror Funding and Fake Currency (TFFC) Cell has been constituted in National Investigation Agency (NIA) to conduct focused investigation of terror funding and fake currency cases.
  - by using new surveillance technology, deploying additional manpower for round the clock surveillance, establishing observation posts along the international border, erection of border fencing and intensive patrolling.

- v) A Memorandum of Understanding (MoU) has been signed between India and Bangladesh to prevent and counter smuggling and circulation of fake currency notes.
- vi) Training programmes are conducted for the Police officials of States and of Nepal and Bangladesh to sensitize them about smuggling/ counterfeiting of Indian currency.
- vii) The Reserve Bank of India has taken various measures including augmenting security features on bank notes so as to render counterfeiting difficult and expensive and has been running awareness programmes for public and cash handlers so as to facilitate detection of counterfeit.
