UPDATE ON DDU-GKY SCHEME

911 SHRI P. WILSON:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the State-wise breakup of beneficiaries and funds allocated under the Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY);
- (b) under the DDU-GKY, the Central Government is contributing ₹ 6000 (CTC) as the minimum salary to all trained youth, whether the Ministry is contemplating an increase in that contribution; and
- (c) the data indicating the job retention percentage of the youth trained under the concerned scheme?

(a) State-wise break up of total number of beneficiaries of Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY) since inception till November, 2022 is given in the **Annexure**.

As DDU-GKY is a demand driven scheme, funds are not allocated State-wise under the scheme. However, details of budget allocation for DDUGKY from 2014-15 till 2022-23 is given below :-

(b) No Salary to the trained candidate is being paid by the Central Government under DDU-GKY Scheme. Under DDUGKY, for a trained candidate to be considered as placed, the following is the salary criteria:

Duration of the Training Course completed successfully	Minimum Salary* in the job to be considered as placed in case of placement within India (Rs.)	Minimum Salary in the job to be considered as placed in case of placement abroad (Rs.)
3 months	6000/-	25000
6 months	8000/-,	
9 months	12000/-	
12 months	15000/-	

*minimum salary or the minimum wage of the State, whichever is higher

(c) No study has been done on job retention percentage of the youths trained. However, under DDU-GKY, a trained candidate is treated as placed only after he/she remains employed for a continuous period of 3 months.
