### MGNREGS IN ANDHRA PRADESH

#### 916 SHRI SUBHAS CHANDRA BOSE PILLI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether all registered workers have been provided 100 days' work under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS);
- (b) if so, the State-wise details thereof and if not, the reasons therefor;
- (c) the district-wise details of the number of workers who got 100 days' work under MGNREGS in Andhra Pradesh in last three years as against the number of registered workers; and
- (d) the details of funds allocated and utilised during the last three years?

#### ANSWER

### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a)&(b): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment Scheme which provides for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work.

### It provides livelihood security, i.e. fall back options for livelihood for the rural households, when no better employment opportunity is available.

State/UT -wise details of households completing 100 days of employment under Mahatma Gandhi NREGS in the financial year 2019-20, 2020-21, 2021-22 and current financial year 2022-23 (as on 10.12.2022) is given at **Annexure-I.**

(d): Mahatma Gandhi NREGS is a demand driven wage employment scheme. There is no State/UT-wise allocation of funds under Mahatma Gandhi NREGS.
