As informed by Department for Promotion of Industry & Internal Trade (DPIIT), the Government with an intent to build a strong eco-system for nurturing innovation and startups in the country launched Startup India initiative on 16th January 2016. Information on the basis of Scheduled classes (SCs and STs) is not compiled. The State-wise details of recognised start-ups across the country as on 30<sup>th</sup> November 2022 are at **Annexure I**.

For scaling up of MSMEs, the Government has announced the Self Reliant India Fund with the objective to channelize funds to MSMEs as growth capital, in the form of equity or quasi-equity for growth of MSMEs. As informed by NSIC Venture Capital Fund Limited (NVCFL) SPV, as of now, no SC/ST beneficiary has availed the benefit of the scheme. The State-wise details of MSMEs assisted across the country as on 31<sup>st</sup> October 2022 are at **Annexure II**.
