**UDYAM REGISTRATION FOR MSMEs SECTOR**

1396. SHRI M. SHANMUGAM:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of new registration of Micro, Small and Medium Enterprises (MSMEs) through 'UDYAM Registration' for Ease of Doing Business, during the last two years;
- (b) the number of employment generated through MSMEs sector during the said period, State-wise;
- (c) the details of assistance being extended to MSMEs sector under Atmanirbhar Bharat; and
- (d) the details of number of MSMEs benefited from these schemes, State-wise, during the last two years?

(a): The number of new registrations of Micro, Small and Medium Enterprises (MSMEs) done and classified on Udyam Registration Portal during the financial years 2021-22 and 2022-23(as on 14.12.2022) are as under:

Financial Year	No. of new MSME registration
2021-22	51,54,868
2022-23 (as on 14.12.2022)	46,03,307

(b): The details of State-wise employment generated in the MSME sector during the financial years 2021-22 and 2022-23(as on 14.12.2022) are at **Annexure-I**.

(c)&(d): The Government has taken a number of initiatives under AatmaNirbhar Bharat to support the MSME Sector in the country. These include:

- i. Rs. 5 lakh crore Collateral Free Automatic Loans under Emergency Credit Line Guarantee Scheme (ECLGS) for business, including MSMEs.
- ii. Rs. 50,000 crore equity infusion through Self Reliant India Fund.
- iii. New revised criteria for classification of MSMEs.
- iv. No global tenders for procurement up to Rs. 200 crores.
- v. "Udyam Registration" for MSMEs, for Ease of Doing Business
- vi. Launching of an online Portal "Champions" in June, 2020 to cover many aspects of e-governance including redressing grievances and handholding of MSMEs.
