**MSMEs SHUT DOWN DURING COVID-19**

1398. SHRI RANDEEP SINGH SURJEWALA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of Micro, Small and Medium Enterprises (MSMEs) which exited business during the last five years, starting from May 1<sup>st</sup> 2017, category-wise;
- (b) whether it is a fact that 14 per cent MSMEs exited business during COVID-19 as reported, if not, then exact number thereof;
- (c) the State-wise funds allocated to MSMEs out of ₹ 5 Lakh Crore “Emergency Credit Line Guarantee Scheme announced, post COVID-19; and
- (d) the State-wise funds allocated to MSMEs out of ₹ 50,000 crore equity infusion through MSMEs Self-Reliant India Fund?

(a) & (b): The details of category-wise number of Micro, Small and Medium Enterprises (MSMEs) which exited business during the last five years, as per Udyog Aadhaar Memorandum (UAM) and Udyam Registration Portals, are as under:

From the launch of Udyog Registration Portal on 01.07.2020 to 14.12.2022, 1.27 crore enterprises have registered, of which 25,006 exited business which constitutes 0.002% of the total MSMEs registered on Udyam Registration Portal.

(c): The State-wise details of amount guaranteed to businesses, including MSMEs under Emergency Credit Line Guarantee Scheme are at **Annexure-I**.

(d): Self Reliant India Fund scheme is a central sector scheme and the funds are not allocated. State-wise. The Ministry of MSME has sanctioned and released Rs. 343.73 crore to National Venture Capital Fund Limited (NVCFL) since inception. As on 30.11.2022, total 32 Daughter Funds have been empanelled with NVCFL and by way of investing of Rs. 2,335 crore, 125 MSMEs have been assisted. The State-wise details of MSMEs benefitted are at **Annexure- II**.
